



## MISSIONS SERVICE AGREEMENT

Be it known to all men that this agreement between the signatories is binding.

This agreement is between CanAmera Baptist Missions International, a ministry of Pembina Valley Baptist Church, 120 Manitoba Road, Winkler, Manitoba, of the first part, and \_\_\_\_\_ Baptist Church, \_\_\_\_\_ of the sending church in the second part, and missionary \_\_\_\_\_ of \_\_\_\_\_ in the third part.

Whereas CanAmera Baptist Missions International as a ministry of Pembina Valley Baptist Church is authorized to act to assist local churches in the sending out of missionaries, the said CanAmera Baptist Missions International undertakes to forward funds to missionaries on the field who are carrying out the approved ministries of CanAmera Baptist Missions International and their sending church. The missionary is considered an agent to extend the ministry of CanAmera Baptist Missions International and his/her sending church in the country of \_\_\_\_\_. All funds are to be used for the furtherance of the Gospel in fulfillment of the "Great Commission" of Jesus Christ, according to the King James Authorized Version of the Word of God as laid out in Matthew 28:18-20.

CanAmera Baptist Missions International hereby acknowledges that missionary \_\_\_\_\_ has been qualified and accepted to act as a missionary agent with CanAmera Baptist Missions International in the country of \_\_\_\_\_. The said \_\_\_\_\_ having agreed to abide by all the provisions and rules of CanAmera Baptist Missions International is hereby recognized to be entitled to all the rights, privileges and services of a missionary agent of CanAmera Baptist Missions International.

Should the situation arise that CanAmera Baptist Missions International and \_\_\_\_\_ Baptist Church are unable to agree to a course of action in these matters, CanAmera Baptist Missions International reserves the right to sever any ties with missionary \_\_\_\_\_, and \_\_\_\_\_ Baptist Church will assume all responsibility in the matter. *Initial* \_\_\_\_\_

Missionary \_\_\_\_\_ acknowledges and accepts that this is the method in which all matters of discipline and recall will be dealt. *Initial* \_\_\_\_\_

Missionary \_\_\_\_\_ agrees that any disputes, misunderstandings or criticisms of CanAmera Baptists Missions International, its leadership, his/her sending church, other missionaries and mission boards, are not to become matters of discussion with others. All such matters are to be brought to the attention of CanAmera Baptist Missions International and the sending church first.

Missionary \_\_\_\_\_ further understands that his/her ministry must always remain within the established parameters of his mission project. Further any work undertaken must be compatible with the policies and mission statement of CanAmera Baptist Missions International and his/her sending church.

Missionary \_\_\_\_\_ acknowledges that it has been explained to him/her that compliance with Canada Revenue Agency policies demands certain reporting and control systems be put in place, especially in the case of foreign field projects. Therefore, monthly reports on the work being done and quarterly financial reports of all funds expended must be sent promptly to CanAmera Baptist Missions International and the sending church.

Failure to comply with the previous three sections will be cause for dismissal and the immediate stopping of any further financial support.

CanAmera Baptist Missions International undertakes to fulfill its obligations to take care of funds for missionary \_\_\_\_\_ as a matter of trust.
